#### Traffic Management

Ref 1: LCAS202002 - New Road jw Long Road, Canvey Island - Signage Request for review of signage and measures to highlight the No Entry into New Road from Long Road. Cllr May informed he had spoken to the police. A discussion was had regarding the issues with people going the wrong way out of the one-way road. TB did write to the shop owner, but it didn't have much effect. The HLO/JS missing no entry sign is in the process of being replaced. JS to speak to maintenance team to make sure it is in the programme. However, in the meantime this will be validated to replace the missing sign and look at other measures to highlight the No-Entry. HLO Ref 3 LCAS212005 - Daws Heath Road, Hadleigh - Traffic calming Awaiting speed and volume survey data. SA updated that this is now in place. Cllr Hart informed that it isn't quite in Cllrs the right location. Cllr Hart to email Param with exact location, to repeat the survey. Members were asked to be as specific as possible when submitting requests and to drop the pin as near as they can on the map. Or provide details such as house number, Lamp Column number etc. HLO





Ref 4: LCAS212006 - West Crescent, Canvey Island – Grasscrete Validation completed. Due to the size and nature of the work required, it is recommended that a design only scheme be undertaken in the first instance to ensure a robust design is produced that takes into account existing drainage and level requirements. A detailed set of scheme costs will also be obtained as part of the design process. Cllr Anderson asked how long before this is done. SA informed that this item has not yet been commissioned. If the panel decides to fund it, it could go ahead next year, if agreed.	HLO

This Schemes Awaiting Funding List identifies those scheme requests, which have been received for the consideration of the Castlepoint Local Highways Panel (LHP). In February 2022 it was agreed, at ECC Full Council, that the 2022/23 Capital Budget for the twelve Local Highway Panels would include the previously agreed additional funding of £200,000.

It is also now the intention that Casualty Reduction Sites across the County are funded from a central pot of monies derived from the existing LHP funding allocations. This will reduce the overall yearly budget allocation to each Panel, as detailed in the summary below.
