4. Matters Arising from the Minutes of the Previous Meeting

In respect of item 4 John Gili-Ross highlighted the lack of progress on the feasibility study for West Bergholt.

In respect of minute 6 Schemes Awaiting Further Funding, it was noted that the Panel would be making further funding allocations at this meeting.

5. Colchester Active Travel Fund Schemes – Update

Julian Sanchez provided a presentation giving an update on the Colchester Active Travel Fund schemes, and in particular the emerging School Streets model. This was trying to encourage sustainable travel journeys and a better balance in the east/west and north/south corridors. An important element of this was trying to encourage active travel to schools. It was recognised that not all parents attended the nearest school and that a number would have to travel. The aim was to make it easier for them by identifying drop off points which would enable children to walk or cycle the last part of the journey.

This initiative built on the SUSTRANS and 3 PR schemes, but it was recognised that some schools needed extra support. The Active Travel Toolkit had been designed to provide this support, and a two-phase project was underway:

Phase one: this would entail engaging with communities and understanding the barriers to sustainable journeys. It would involve working with SUSTRANS to facilitate discussion and identify parents who might benefit from using drop off points.

Phase two: this would involve a range of solutions based on local circumstances – this could involve behaviour change, improved infrastructure, timed road closures.

It was recognised that there had been erroneous literature circulated about Active Travel in Lexden, based on a misunderstanding of how the scheme would operate.

The Panel discussed the contents of the presentation and the Active Travel Fund schemes and raised the following issues: -

- The best way of engaging with schools and encouraging them
 to take part, especially given the competing demands on the
 time of school managers. Lessons needed to be learnt from
 the implementation of 3PR. It was emphasised that once
 schools agreed in principle to joining the scheme, there was
 considerable support offered through ECC and Sustrans.
- The need to clear and accurate information to be provided to residents and schools to lessen concerns.



- Wider community engagement was key not just engagement with parents at the relevant schools. Greater use should be made of Councillors who had networks to disseminate information and key messages.
- The range of solutions being offered to schools was welcomed – a one size fits all approach would not work. A greater emphasis was needed on the design of schools – very few had proper drop off or parking provision and greater cooperation was needed between Highways and Education services.
- Timing was important information should be included in Induction Packs and be given to parents before travel patterns were established.
- There was a need to understand the views of all parents and understand that for some parents, and especially in rural areas, there was little alternative to car journeys to school.

The Panel thanked Julian for his presentation and the update.

6. Report on Funded Schemes 2021/22

The Panel considered a report providing an update on the current position of all the schemes which the Colchester Local Highway Panel has recommended for inclusion in their 2021/22 programme.

Jon Simmons confirmed the Panel had £137,500 available for further funding of schemes, which would be allocated in the next item.

The Panel noted the funded schemes set out in the report and received updates or made comments as follows: -

No. 5 Monkwick Cycleway Improvements: A shortened scheme costing £221,000 was now proposed.

No. 2 Station Road, Wivenhoe, Bus Stop Improvements: Scheme was now complete.

No. 13 The Commons, Colchester, Zebra Crossing: Officers were liaising with residents to see if comments made should be considered as formal objections.

Nos 27 and 28: School Streets schemes, Wivenhoe: further work with the consultant was required with school and residents to identify feasible schemes for 2021/22. The Panel would be kept informed.

No 38 B1508 Colchester Road, West Bergholt - Pedestrian crossing improvements: Officers were working to get the scheme delivered as soon as possible. It was noted that the scheme was in Constable Division, not Abbey as listed on the report.



In discussion, the Panel sought further information as to the reasons for the continued delay in the implementation of the scheme. Concern was expressed that further delay once the feasibility study had been completed could lead to the loss of the funding. Jon Simmons indicated that whilst the indicative date was Quarter 4, he was seeking to have this brought forward. David Gollop also indicated that he would look at the scheme. The frustration on the delay in the scheme was understood and further discussion would follow.

Action – ECC officers to look at whether scheme No 38 could be brought forward.

It was suggested that it would be useful for the report to show the date of the scheme and who had made the request for the scheme.

Action – Officers to look at the presentation of the report and whether information on date the scheme was requested and by whom could be included.

The Panel also sought clarification on how Parish Council's should seek help with the funding of highways equipment they were looking to purchase, such as Vehicle Activated Signs. Jon Simmons explained that a policy on this was being prepared but had not yet been finalised. It ws important that Parish Council's took account of maintenance costs when considering the purchase of highway equipment.

7. Schemes Awaiting Funding

The Panel reviewed the schemes on the Schemes Awaiting Funding List to consider the further schemes it wished to fund. Jon Simmons indicated that the Panel had £137,500 of funding to allocate. The Panel could choose to support one large scheme or several smaller schemes, although that could prove more difficult to deliver this financial year. It was also an opportunity to fund schemes that promoted walking and cycling and the modal shift away from car use.

The schemes were classified on a RAG basis and the schemes classified as Red would be reviewed at the September meeting.

Traffic Management Schemes

No. 2: Mersea Road j/w Weir Lane, Blackheath – Kerbs, Verge Improvements – Funding not supported



- No. 3: Bounstead Road/Berechurch Hall Road/Berechurch Road, Colchester - Junction improvement – The Panel was informed that there had several accidents here and the scheme was put forward for funding.
- No. 5: Flagstaff Road, Circular Road East, Colchester Traffic management improvements: Scheme on hold funding not supported.
- No. 13: Ipswich Road near East Street, Colchester Pedestrian crossing improvements: Scheme to be put on hold funding not supported.
- No. 20: Roberts Road j/w Brigadier Road, Colchester RAB improvements: Scheme put forward for funding.
- No 21: West Stockwell Street, Colchester Signage: Scheme to remain on hold funding not supported.
- No. 26: Langham Village Moor Road, School Road, Wick Road & Birchwood Road VAS: Scheme awaiting confirmation of new policy on funding Parish Council schemes. Funding not supported.
- No. 28: Nr 270 Cowdray Avenue Colchester Junction signing/lining improvements: Scheme put forward for funding.
- No. 29: Fordham Fingerposts. This scheme was awaiting further information from Fordham Parish Council around possible third-party funding.
- No. 35: James Parnell Drive & John Mace Road, Colchester Blockwork improvements. Scheme put forward for funding.
- No. 37: Taylor's Road/ Paget Road and Church Hill/Church Street, Rowhedge Width Restrictions. It was noted that this was now a 20mph zone so may no longer be necessary. Funding not supported.

Walking List

- No. 2 Park Lane, Langham New footway: Given the total estimated cost of build was £123,500 the Panel suggested other sources of funding be explored. Funding not supported.
- No. 4: Tyburn Hill, Wakes Colne New footway. The Panel noted the high implementation costs. Funding not supported.
- No. 5: Shrub End Road, Colchester Pedestrian crossing. The Panel noted the significant cost of the scheme and discussed whether it was needed, in the light of LIDL opening nearby.



However, the crossing would give safe access to the garage on Shrub End Road, whose mini supermarket which was heavily used by residents. It would also make journeys safer for children travelling to local schools. Scheme put forward for funding.

No.8: Rectory Hill, Wivenhoe - Street Lighting: Scheme put forward for funding.

No. 20: S/o 18 Gazelle Court, Colchester – Bollard: Scheme put forward for funding.

Cycling

No. 1: Spring Lane Roundabout, Colchester - Traffic management improvements. In view of the costs of the scheme, the Panel considered other sources of funding needed to be explored. Funding not supported.

No. 3: Boxted/Langham to Northern Gateway Sports Facility Colchester – Cycleway. Members of the Panel stressed the importance of cycle routes to give sustainable access to the Sports Park from the villages to the north. It was noted that the costs of the scheme would not be known until the feasibility study was undertaken. It was suggested that access to the site could be improved by upgrading the status of existing rights of way. Funding not supported.

No.5: Monkwick Cycleway Improvements, Maypole - Cycle Route. A Panel member stressed the importance of this scheme, and there had been an accident in 2016. In view of the costs of the scheme it was suggested that other sources of funding be explored, possibly through Active Essex or other Essex County Council cycling funds. In view of the difficulty in funding large schemes, members discussed whether there would be merit on upper limit on the value of schemes. The Panel also enquired as to whether funding could be allocated over a number of years but were advised that ingoing funding would require Cabinet approval. Funding not supported.

Passenger Transport

No 4: Opposite Parsons Field, Crown Street, Dedham - Raised kerbs. The divisional Councillor would check the position on the bus stop. Funding not supported.

No. 7: Flag Name - Scarfe Way Location - Avon Way, Colchester - Bus stop infrastructure: Funding not supported.

No. 9: Flag Name - Blue Row Location - East Mersea Road, West Mersea - Infrastructure upgrade. The divisional Councillor would check the position on usage of the bus stop. Funding not supported.



No. 10. Malting Road, Peldon - Bus stop improvements. The views of the divisional Councillor on priority of the scheme should be sought. Funding not supported.

Public Rights of Way

No. 1: Footpath 185, Artillery Barracks Folley – Surfacing. The Panel noted that there was development nearby that could affect the scheme and may be a source of potential section 106 funding. Funding not supported.

No. 2 Footpath 70, Myland - Surface upgrade. The Panel agreed to leave the scheme on hold until the specification was received. Funding not supported.

No. 4 Cambridge Road, FP198 - Surface improvements. The Panel considered this was an important scheme and the problems on Cambridge Road needed addressing. However, given this was a popular route to the Maldon Road, it did not consider that closing the footpath was a practical option. There was a larger ongoing maintenance issue that could be an issue for the Local Highway Panel. Funding not supported.

No. 5: Footpath 5 off Tollgate Road, Stanway - PRoW access improvement. It was suggested by Panel members that a wider look at the Tollgate area may be necessary, and that there could also be the opportunity to obtain section 106 funding from development in the area. Funding not supported.

Other issues

The Panel discussed an incident where a child had been hit by a car at Tiptree Heath primary school and the possibility of providing funding to implement safety measures, such as railings, at the school. Councillor Mannion indicated that he would be visiting the school shortly to discuss the incident, and that no decision on remedial measures be taken until the issue had been fully discussed and other sources of funding, such as the Parish Council, looked at. An overall co-ordinated approach needed to be taken.

7 Any other business

The Panel discussed issues around the costs of Vehicle Activated Signs and their batteries and how Parish Councils could procure these. David Gollop indicated that ECC would get a fixed price for parishes for VAS but it was important that parishes took account of ongoing revenue costs for batteries and other maintenance costs



	when purchasing VAS. ECC would also provide advice on good practice on charging batteries for VAS.	DG
