This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Epping Forest District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated south of White Bear Lane known as Footpath 62 Stanford Rivers in the District of Epping Forest and shown by a bold continuous line on the order map numbered PROW-23-02 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of White Bear Lane known as Footpath 62 Stanford Rivers in the District of Epping Forest as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-02 contained in this order.
- 3) The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

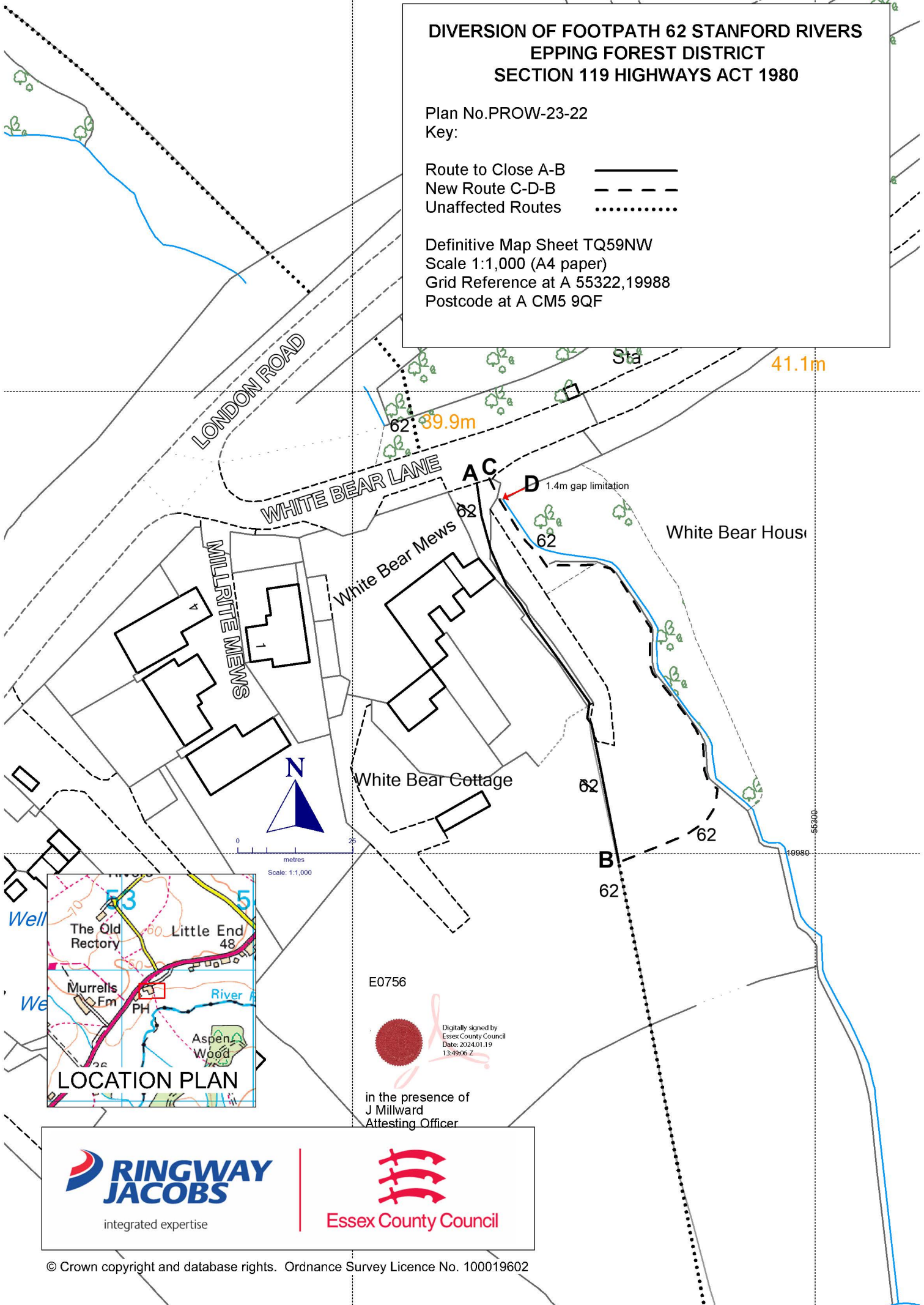
**DIVERSION OF FOOTPATH 62 STANFORD RIVERS

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 62 Stanford Rivers of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 55322,19988 where it connects to White Bear Lane running in a south easterly direction along an access drive alongside buildings and across a field for a total distance of approximately 89 metres to point **B** at grid reference 55325,19979 where it continues unaffected.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at point **C** at grid reference 55322,19988 located approximately 3 metres east of the aforementioned point **A** running in a south easterly direction by the side of an access drive for a distance of approximately 5 metres to point **D** at grid reference 55323,19987 where it passes through a gap to the side of a gate then continuing in a south easterly then easterly then generally south easterly direction around a field edge. The path then continues in a south westerly direction across a field for a final distance of approximately 115 metres to the aforementioned point **B** where it continues unaffected.

(PART 3)

LIMITATIONS AND CONDITIONS

1.

At the point marked D on the order map (PROW-23-2) directly adjacent to the south western side of a gate (grid reference 55323,19987)

The right of the landowner to maintain a gap of 1.4 metres subject to its removal should the limitation become unnecessary whereby an available width shall remain of 2 metres, this being the dedicated width of the path as specified in Part 2 of the Schedule


