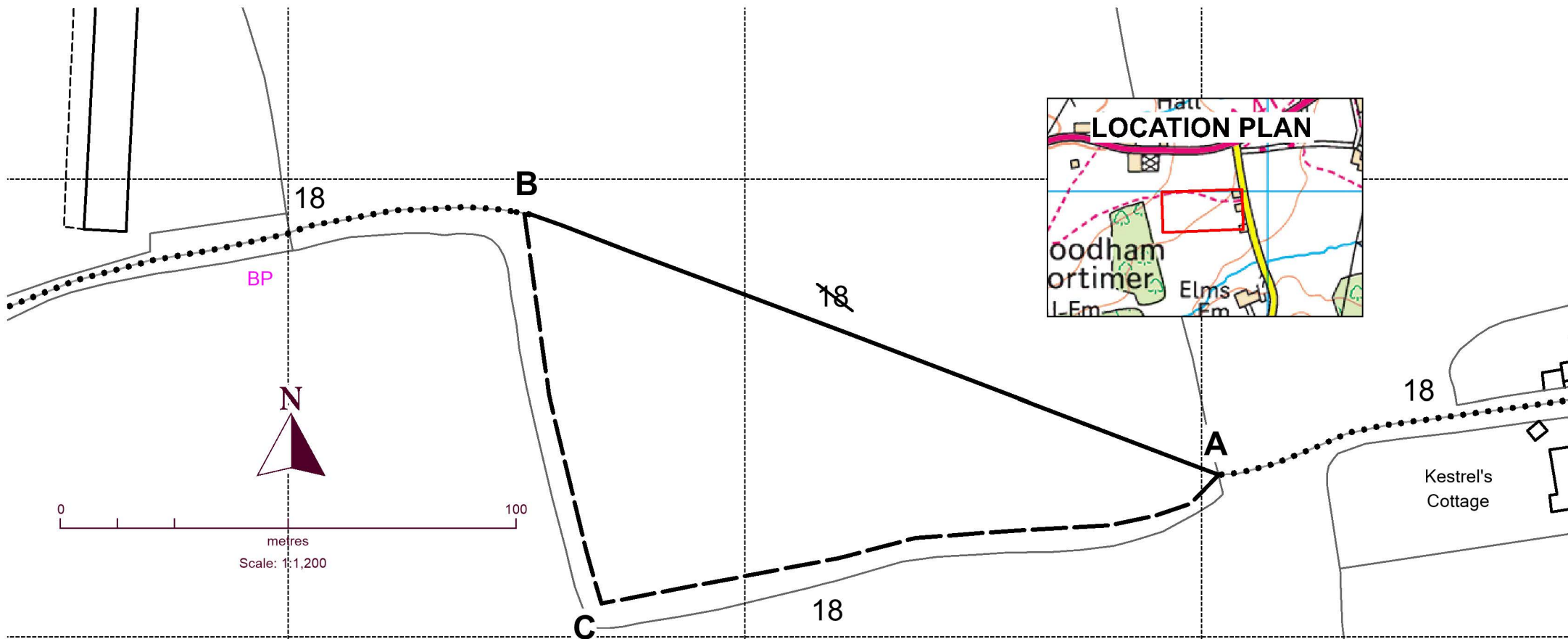
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Maldon District Council have been consulted as required by section 120(2) of the 1980 Act.




BY THIS ORDER:

- 1) The public right of way over the land situated west of Kestrel’s Cottage known as Footpath 18 Woodham Mortimer in the District of Maldon and shown by a bold continuous line on the order map numbered PROW-23-33 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
  
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated west of Kestrel’s Cottage known as Footpath 18 Woodham Mortimer in the District of Maldon as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-23-33 contained in this order.

**SCHEDULE**

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 18 Woodham Mortimer of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 58280,20493 west of Kestrel's Cottage running as a cross-field path in a north westerly direction through a vineyard for a total distance of approximately 162 metres to point **B** at grid reference 58265,20499 where it continues unaffected.


DESCRIPTION OF SITE OF NEW PATH OR WAY

A Footpath being 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned point **A** running in a south westerly direction along a field boundary for a distance of approximately 140 metres to point **C** at grid reference 58266,20490 then continuing along the field boundary in a northerly direction for a final distance of approximately 87 metres to the aforementioned point **B** where it continues unaffected.


