	Cllr Mrs June Lumley, Mrs Cheryl Roe and Cllr Ian Ward declared a non-pecuniary interest by virtue of membership of Rayleigh Town Council.	
	Cllr Mike Steptoe declared a non-pecuniary interest by virtue of membership of Barling Magna Parish Council.	
	Cllr Phil Shaw declared a non-pecuniary interest by virtue of membership of Stambridge Parish Council.

3.	The minutes of the meeting held on 13 September 2021 were agreed as a correct record.	
4.	Cllr June Lumley made a comment on the penultimate paragraph on page 3 of the report from 13 September 2021 and that the Panel did ask for each Member to be given a list of their signs in the area so that it can be identified which are in operation or not. The list has not been sent as of yet.	
	Cllr June Lumley raised a question in relation to Thorpe Road, Hockley – Vehicular Access Restriction and advised that Members were still waiting for an update.	
	A comment was raised around Barling Road, Great Wakering on page 8 of the report that the speed management strategy was still not provided to Members. Rissa Long advised that she did send it to Members.	
	Cllr Ian Ward asked whether there was any progress on Brook Road, Rayleigh Weir and it was advised that this was not included on the program but would have been in progress when the December's meeting was being scheduled at the end of 2021.	
	A comment was raised around the last paragraph on page 9 of the report noting that the information was still not sent to Members.	
	Cllr June Lumley made a point with regards to the coastal path and whether there were any maintenance preparations as the footpaths are part of the highway network and the responsibilities that the LHP had going forward. The indication from Sonia Church was that she was unsure but would return to the Panel and advise of responsibility. It was noted that Sonia Church did not return to the Panel.	
	Cllr Ian Ward asked a question with regard to the rangers whether they would be able to deal with the clearance of highways and footpaths; however, Cllr June Lumley clarified that public rights of way are not covered within their work range. Rissa Long further clarified that complete off-track rural settings would fall under the public rights of way Team as opposed to the rangers. Overall, it was observed by the Chairman that areas had been maintained via the Town Council that liaised with a small team at

	Cllr Mike Steptoe requested another meeting with Ian Henderson to discuss some outstanding matters. The Chairman agreed and requested the same.	JD
	James Drabwell clarified that he would participate in any future meetings to be a part of the discussions and provide advice.	
6.	Rochford Town Centre – Market Square Improvements The works will commence imminently, however still awaiting on the results of the feasibility study. Still unsure on the timescales.	
	Star Lane, Great Wakering – Traffic Calming This was completed on 25 November 2021.	
	Rochford Garden Way, Rochford – Grasscrete This was completed in November 2021.	
	Twyford Avenue, Great Wakering – Grasscrete This will be completed in Q4 and the order had been placed.	
	Nelsons Gardens, Rayleigh – Footway The works are carrying on as scheduled and some sort of tarmac had been put down but unable to find out who was requested to do it. The tarmac had already started to fail; therefore it will be dug up and works will continue as planned.	
	Ashingdon Road, Rochford – Bollards This was delivered by the Capital Footway Team. Currently unsure when this will be delivered, but an update will be provided.	JD
	Main Road, Hockley – Bollards This was completed on 24 November 2021.	
	New Road/Shoebury Road, Great Wakering – Signing	

This will be finished in Q4 and the works are on schedule.

High Street/Eastwood Road/Crown Hill, Rayleigh – Mini RAB improvements

Undergoing feasibility studies.

A127/A129 Rayleigh Weir Roundabout – Lane Signage and Markings

Undergoing feasibility studies.

Cllr June Lumley pointed out that the Panel requested a report outlining previous studies in particular areas of the town centres regarding laybys. Few Members received the report. The Chairman advised that all LHP Members must receive the report.

Cllr Ian Ward commented that a Town Centre Modelling – Option 3 report had been circulated.

It was pointed out that the responsible officer works one day a week as an Essex Highways Officer, who discovered that there was a congestion by the library and if the layby was to be moved to a different place, then the traffic would be able to move faster to improve the flow through Rayleigh.

Cllr June Lumley responded that this suggestion was not suitable as it is between two mini round-abouts that are currently being investigated for safety measures. It would be impossible for a bus to park on the A129 Lane.

Cllr Mike Steptoe suggested that given the fact this is a particular problem for Rayleigh that has been happening for a number of years, a separate meeting should be arranged to discuss this particular point.

Ashingdon Road, Rochford – Zebra Crossing UpgradeThis was delivered by the Capital Footway Team.

Cllr Mike Steptoe queried whether the roadworks along Ashingdon Road will be delivered at the same time. James Drabwell will confirm with Cllr Steptoe outside of the meeting.

Little Wheatley Chase, Rayleigh – 20 When Lights Flash

This is to be removed from the program as it has been cancelled.

Wakering Road, Great Wakering – 40mph Speed Limit

This was completed on 18 January.

PROW 71 Rayleigh – Street Lighting

Cllr June Lumley commented that she had a number of conversations with the District Council that are not prepared to pay for the maintenance to fund the installation of the lighting because it is not their land. The Council suggested a route that was through the top of the gardens to shorten the route onto what partly was under Essex Highway responsibility. The Town Council had already committed £10,000 into a £39,000 scheme or the installation to ensure pedestrian safety, however this item was to be removed from the schedule which would be reported back to the Town Council.

Anchor Lane, Canewdon – Village Gateway Repositioning

No current updates on this item but scheduled for Q4 to be delivered.

Little Wakering Road, Barling - Wig-Wag

No current updates on this item but scheduled to be delivered in Q4.

Rissa Long advised that this was part of the normal maintenance programme with Essex.

Cllr Mike Steptoe pointed out that there seemed to be confusion on this particular point regarding lights in Wakering that do not seem to be working. It must be clarified who is responsible for the maintenance.

Rissa Long responded that the funding for the maintenance of these units was falling under LHP and it would be reported in the same manner through the County Council but the funding comes out of a different source.

Cllr Steptoe requested James Drabwell to send a list of the precise affected locations.

Coronation Close, Great Wakering – Grasscrete

The works are currently being carried out.

Cllr Mike Steptoe commented that the works are currently ongoing; however, there are issues with the methods of delivery due to various problems underground. The original schemes went the full length of Coronation Close down to the entrance provided by Rochford District Council and the last section does not appear to have been done.

James Drabwell advised that he had a quick conversation with one of the design engineers and the part of the grass verge area did not show particular access to it, hence the engineers decided to stop. James will come back to Cllr Steptoe offline.

The grass creak was changed to concrete; however, James Drabwell was unable to confirm whether the cost of the scheme would have been affected. James will come back to LHP Members with an update on the costs.

Cheapside West, Rayleigh - Grasscrete

This will slip into 2022/23 and another site meeting will be arranged.

Hall Road, Rochford - Lane Layout

This is down for a change of control.

James to clarify to LHP Members which section of the road is in question.

Upway, Rayleigh – Grasscrete

Works are currently being carried out and this will be delivered soon.

Little Wheatley Chase, Rayleigh – Pedestrian Crossing The status has not changed with the CMA being signed. Scheduled to be delivered in Q4 between now and March as a completion date.

Fountain Lane, Hockley – Unsuitable for HGVs sign Funded scheme and will slip.

Church Road, Hockley – Narrow Road Signage Funded scheme and will slip.

Brinkworth Close, Hockley – Staggered Barrier This scheme is due to be cancelled – LHP Members unanimously agreed to have this removed.

Main Road, Hawkwell – Zebra Crossing Visibility Internal actions – decision from LHP not required.

Hall Road/West Street/Ashingdon Road, Rochford – Casualty Reduction Scheme

This will slip into Q4.

Some Members of the LHP had seen video footage of the roundabout due to outside influence. Members commented that the roundabout is not utilised in the way it should be and poses great threats given its area in close proximity to the river and schools. There is no space to enlarge the junction.

A1245/Chelmsford Road Battlesbridge – Casualty Reduction Scheme

This will slip into Q4.

Poynters Lane/Great Wakering Road – Casualty Reduction Scheme

This will slip into Q4.

Post Construction Safety Audits

This will be dealt with by the Safer Roads Partnership.

Rissa Long advised that every panel has a nominal figure that is allocated to undertake audits of the schemes that are installed to check that everything is as it should and meets the desired objectives. The cost outlined is the cost throughout the year.

James Drabwell advised that there are no significant updates on the schemes. The LHP Panel will be notified in the upcoming meeting scheduled in March to discuss Q1 2022 financial year's available budget which will also be dependant upon the Budget Council meeting in February.

The Traffic Management Scheme is still awaiting. This relates to section of Hall Road by roundabout of Cherry Orchard going west to Hawkwell. Engineers are to look at the road marks and the way that the lines are marked on the road. Possibly looking at double white lines with chevrons in between to encourage people not to overtake.

This has not yet been actioned.

This application would not have appeared on this agenda but will appear on the next agenda.

TRAFFIC MANAGEMENT

Thorpe Road, Hockley – Vehicular Access Restriction This is to be removed.

Cllr Laureen Shaw advised that she is still awaiting for the Cabinet Member to come back. This is to be actioned before the next meeting.

James Drabwell to provide LHP Members with an update.

Thorpe Road, Hockley/Main Road, Hawkwell – HGV Restriction

Currently waiting on further information so that a firm update can be given to Members. Awaiting for a site meeting to be arranged as this has been an issue for a period of time.

Cllr Steptoe advised that the main issue here is that the piece of the main road is a private street and does not permit car and pedestrian access.

Paglesham Road, Paglesham – Rucks in Road Signs No update.

High Road/Brook Road – Signing No update.

High Road/Brook Road, Rayleigh Weir – Junction Improvements

Undergoing feasibility study.

Daws Heath Road, Rayleigh – Horse Warning Signs No update – still in validation.

Shoebury Road – Great Wakering

No update – still in validation.

Cllr Mike Steptoe observed that the validation process takes up a significant amount of time.

Rissa Long clarified that this is due to the same engineers dealing with all validation cases and these tend to be low priority so that the schemes can be resolved first. The intention is that all items that are in validation will be resolved before the funding is considered.

James Drabwell to update Members on which validation schemes are a priority.

Cllr Laureen Shaw observed that there are 401 schemes with 33 engineers and questioned whether some of those schemes can be pushed forward.

Rissa Long responded that there is a new design manager and the validation process is something that is being considered going forward to bring improvements and make the Panel run smoother. The priority at the moment are the schemes that are already on the system.

Shoebury Road, Great Wakering

In validation and awaiting funding.

James Drabwell advised that there are no updates on schemes that are in validation process.

Crown Hill/Castle Terrace, Rayleigh – Visibility
Cllr June Lumley raised a question regarding the
overgrown high hedge and the narrowing footpath that is
supposedly with the Enforcement Team whether there are
any updates.

James Drabwell advised that he was in contact with the Enforcement Team and Sonia Church had gone to visit the site. It was advised that the hedge was to be cut back by the end of February.

James Drabwell would provide an update via email to the Chairman. James to visit the site and check whether the hedge had been cut down by the agreed timescale and report back to LHP Members.

Barrow Hall Road, Little Wakering – Traffic Management Improvements In validation.

Great Wheatley Road, Rayleigh – Speeding
It was pointed out that this is a continuous series of accidents with huge congestion issues due to the high amount of accidents that creates traffic all the way to Southend.

Cllr Mike Steptoe suggested a CCTV survey. James to contact Cllr Steptoe offline.

WALKING

Pedestrian Crossing – London Road, Rayleigh Currently waiting for the development to be agreed.

Southend Road, Rochford – Crossing PointCllr Mike Steptoe raised a point that it has been agreed that crossing needs to installed there; however, currently

there has been no confirmation as to whose responsibility this would be.

Rissa Long advised that if a signalised crossing is recommended, it means that the traffic is too fast for a standard crossing to be considered. A signalised crossing where the mph is over 35 is recommended as opposed to a zebra crossing.

The feasibility study will provide further details.

Castle Road, Rayleigh – Zebra Crossing Update
This item has been on the agenda for a significant amount of time.

James Drabwell to contact LHP Members to arrange a sitevisit.

Anchor Lane, Canewdon – Pedestrian Crossing This can be removed.

PASSENGER TRANSPORT

Members pointed out issues with Hall Road, however James Drabwell advised that he has been in contact with Passenger Transport group and it will appear in the system for validation and appear on the next agenda.

Anchor Lane, Canewdon - Bus Shelter

Cllr Laureen Shaw advised that the Parish Council wanted to buy it which seemed impractical. The Parishes identified all bus stops within their areas and the information was provided.

Rissa Long advised that there were some papers sent out to County Members regarding the shelters but unsure what this meant for the panels and whether the LHP would still consider bus shelters. Rissa to provide further updates following a meeting regarding this matter.

Cllr Ian Ward pointed out that some pavements are not wide enough to sustain a bus shelter, which means that there would be instances where the bus stops would need to be moved. This in itself would pose a major challenge.

Cllr Mike Steptoe advised that Barling Parish Council are looking to replace 3 of their bus shelters and one does require a licence even though it is on privately owned land.
