	<p><b>Apologies for Absence:</b></p> <p>Apologies for absence were received from Councillor K Barnes (BALC), Councillor G Butland (ECC), N Jones (BDC) and Councillor P Rawlinson (BALC).</p> <p><b>Declarations of Interest:</b></p> <p>There were no interests declared.</p> <p><b>Public Questions:</b></p> <p>There were no questions asked, or statements made.</p>	
3.	<p><b>Minutes:</b></p> <p>The Minutes of the meeting of Braintree Local Highways Panel held on 12th January 2023 were approved as a correct record and signed by the Chairman.</p>	
4.	<p><b>Matters Arising from the Minutes of the Meeting Held on 12th January 2023:</b></p> <p><u>Minute 4 - 'Matters Arising'</u></p> <p>Reference was made to three action points which had been recorded in the Minutes of the Panel's two previous meetings and the following updates were provided for each of them:-</p> <p><u>Speed Surveys</u>  <u>Action:</u> - Dan Maclean, Essex Highways, had been requested to circulate to the Members of the Panel a copy of a document explaining how Essex Highways assesses speed limits.  <u>Update:</u> It was reported that the guidance document was being updated and it would be circulated when available.</p> <p><u>'Tru-Cam' Automated Speed Checking Device</u>  <u>Action:</u> - Dan Maclean, Essex Highways, had been requested to circulate details of the 'Tru-Cam' automated speed checking device and its cost to the Members of the Panel.  <u>Update:</u> - It was reported that an update on this matter was awaited.</p> <p><u>Damaged and Outdated Directional Signs</u></p> <p>At the last meeting of the Panel, reference had been made to a number of road signs across the District which were damaged, obscured, or out of date and which reflected poorly on the image of the area, particularly on entry to and exit from the District.</p>	

	<p><u>Action:</u> - Dan Maclean, Essex Highways, had been requested to investigate if a proactive approach towards the replacement and maintenance of road signs in the Braintree District might be implemented; how a sum of approximately £100,000 allocated by Braintree District Council for such work in Braintree town might be utilised; and to ascertain the outcome of a joint discussion between Essex County Council and Braintree District Council on this matter.</p> <p><u>Update:</u> - It was proposed that a list of damaged and outdated signs should be prepared.</p>	
<p><b>5.</b></p>	<p><b>Funded Schemes 2022/23:</b></p> <p>Consideration was given to a report on the Panel's Funded Schemes for 2022/23, which had been recommended for approval. The report provided an update on the current position of all schemes in the 2022/23 programme of work.</p> <p>Members of the Panel were reminded that funding of £407,600 had originally been allocated to Braintree Local Highways Panel for the year 2022/23. Subsequently, further sums of £100,000 in 2021/22 and £200,000 in 2022/23 had been allocated, together with a sum of £177,594 following the re-profiling of schemes in 2021/22. It was reported that £689,000 of the Panel's budget had been allocated to various schemes within the programme of work and that £59,612 had been allocated specifically to casualty reduction schemes. This meant that a total of £136,582 would have remained in the 2022/23 capital budget. <p><b>6.</b></p>	<p><b>Schemes Awaiting Funding:</b></p> <p>Consideration was given to a ‘Schemes Awaiting Funding’ report, which included details of requests received for funding from the Panel’s budget for the year 2023/24.</p> <p>Members of the Panel were advised that Essex County Council had agreed that funding for all Local Highways Panels should remain the same as in 2022/23. This amounted to £407,600 for the Braintree Panel. As in 2022/23, a proportion of the Panel’s fund, amounting to £59,612, would be allocated to casualty reduction schemes. In addition, in 2023/24 part of the Panel’s fund would be set aside for carriageway improvement schemes. This would amount to £144,189. This would reduce the budget available to the Panel. However, for 2023/24 an additional £203,800 had been allocated to the Panel for footway schemes and a further £203,800 had been allocated to the Panel for footway minor works.</p> <p>It was reported that details of proposed carriageway improvement schemes; footway schemes; and footway minor works would be sent to Members of the Panel, who would be asked to prioritise the schemes that they wished to be undertaken in 2023/24.</p> <p>As referred to when considering the previous Item, Members of the Panel were reminded that six schemes programmed for completion in the financial year 2022/23, including the funding allocated to them, would be carried over for completion in 2023/24. However, as Essex County Council would be required to sign off these schemes before they could progress it was unlikely that this would occur until June 2023. In the circumstances, it was proposed that the Panel should agree to recommission these schemes so that funding would be available for re-allocation when available.
